Vacancy Announcement for Editor in Chief Position

Arba Minch University seeks to assign a competent and committed Ethiopian academic staff for the Editor-in-Chief position for the **Ethiopian Journal of Business and Social Sciences** (**EJBSS**) on merit base.

1. Duties and Responsibilities

The Editor-in-Chief is accountable to PDDD and has the following key roles:

- > Chairs the editorial board members' meetings;
- > Approves the annual plans of the publication;
- > Evaluates the performance of the members;
- > Communicates with authors:
- > Decides whether a manuscript should be sent to reviewers based on the suggestions from the co-editor-in-chief;
- > Selects and assigns appropriate reviewers, and sends the article to the reviewers;
- > Communicates comments from the reviewers to the authors on time;
- > Follows up and collects responses from the reviewers and decides on the status of the manuscripts;
- > Works to improve the visibility of the journal;
- > Ensures the dissemination of the published articles; Selection Criteria for the EB Members of AMU Journals:
- > Creates links with other sisterly national or international journals;
- > Makes the journal to be indexed in national and international databases;
- Obtains an International Standard Serial Number (ISSN) and digital object identifier (DOI) for the journal;
- > Identifies topics for special issues in the journal;
- Delegated some of its roles to Co-Editor-in-Chief;
- > Liaisons of the journal with the public, including scholars, scientific societies, local and international advisory and associate editors.

2. Requirements for the position

The candidate shall have:

- Associate Professor and above with a PhD Degree.
- Editorial board membership experience in internationally reputable journals, nationally accredited journals, and AMU-based journals;
- > Publication experience in internationally reputable journals in the last 5 years
- Peer review experience in internationally reputable journals, nationally accredited journals, and AMU-based journals in the last 5 years;

- Collaboration and Networking track record **over the last 5 years**; This includes: Collaborative and joint research or community development grand project, small-scale research grant, International Junior and Senior/Postdoctoral Fellowships, experience in relevant national/international academic/research boards, associations, societies, number of non-AMU PhD students advised.
- Active participation in research activities of the university in the last 5 years: This includes: Grand research project, small-scale research, special female research project, evaluating research proposals and community service projects, organizing national or international conferences, symposiums, workshops, or summer schools as a member of the main organizing committee, or as moderator, chairman, secretary, and rapporteur experiences
- > Leadership experiences;
- > Service year in higher education institutions;
- Community engagement in the last 5 years;

3. Benefits

Major benefit: Satisfaction with their contribution to the university's vision and its national and international community service achievements.

String benefit: As per the Ministry of Finance directive on Journal Editorial Board payments.
